#### **REVIEW OF FINANCIALS BY PROFESSIONAL ACCOUNTANT**

Income for the 2021 fiscal year was \$45k.

The board is operating under the old Societies Act. Based on the financial limits provided in Section 7(1) of the Societies Act, Climb Yukon Association moved from a category A to a category B society.

The society presented non-reviewed financials as waived by special resolution.

### FINANCIAL REPORT

The Treasurer's report was distributed at the meeting and is available on the website Resources page.

Selected and abbreviated information from the treasurer's report is also included in the 2021-2022 Annual Report.

The reports were reviewed with the members and included the following highlights:

- Year end bank balance of approximately \$14,000.
- Most significant funding was through Yukon Lotteries for the new mats for Porter Creek \$20,000. Total funding for the year was \$38,600.
- Revenue from memberships, drop-in fees, and competitions added to \$5,000.
- Total revenues for 2021 were \$45,000
- Most significant operations expense continues to be liability issuance at \$5,500

### **MEMBERSHIP AND FEES**

Our membership program is currently under review. A proposed change is expected this year. The current membership, which is a suggested donation of \$20 dollars, will remain in effect. Most memberships are purchased for the suggested minimum amount with a small percentage of members offering more. Memberships require renewal annually and memberships are set to expire annually on August 31. Memberships continue to include reduced fees for drop-in bouldering and free shoe rentals. In general, the membership program was a success and brought in over \$2,100 this fiscal year.
